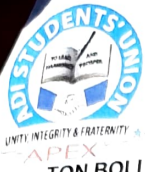
Therefore, we, the Adi Students' Union demands assessment of the movable/immovable property of all members, officials and staffs of APPSC.

The government must prioritize the appointment of Vice Chancellor for the full functionalization of the Arunachal University, Pasighat.

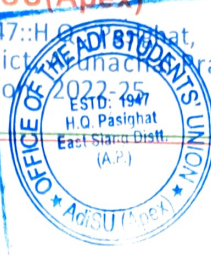
3. **Functionalization of Industrial Training Institute, Pangin :**

5. Fast tracking of investigation of late Tamik Taki Murder Case:


It has been over 9 months since the gruesome murder of Lt. Shri Tamik Taki. We demand for fast track of the case for early justice.
